- Preparation of Detailed Project Reports for the components identified under the (iii) **CGF**
- The funds should be utilized as laid down in the framework of implementation of (iv) the SPMRM.
- Commencement of basic activities on site- achievement of works expenditure to (v) the extent of 60% of the CGF released.
- The release of funds is subject to audit by Internal Audit of Department of Rural (vi) Development.
- Funds should not be diverted for any purpose other than as mentioned at (i) to (vii) (iv) above.

- The State should submit the expenditure statement for Rs 35 lakh immediately as released 3. earlier for ICAP preparation.
- The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.
- This is the first installment. Hence, no Utilization Certificate (UC) is pending. 5.
- The expenditure is debitable to the following Head of Accounts under Demand No. 75 6. Department of Rural Development (2016-17).
